3. The main object of the Trust shall be to help the Educational and Charitable (Trust) Institution and in particular the Educational institution run under the name and style of Bharathidhasanar Matriculation Higher Secondary School at Arakkonam.

The objects of the Trust shall be, a) To build, construct, establish, take over, run, maintain, manage and/or render financial help to any educational and/or Science, medical, engineering vocational and technical subjects or for research in any of all the above; b) The main object of the Trust shall be Education and relief of the poor, without any distinction as to caste, creed or religion; c) To constitute, establish, run, maintain, manage and/or render financial help to one or more polytechnic institutes, Research institutions or other centres for training of men and women in technical, mechanical, scientific similar pursuits; d) To provide for payment of school, of college fees, boarding and/or lodging charges and purchases of Educational books or stationary for poor students; e) To give monetary; f) aid or provide relief for flood or famine or fire or any other natural calamities like earth quake and cyclone; g) To provide financial help for educational and/or maintenance to destitute/deserving poor widows; h) To open orphanage homes or assist in conduct of any institutions for protection of orphans; i) To provide for the construction of building for the accommodation of and conduct schools, colleges, research institutions, medical clinics and dispensaries; j) To

6. a) In the event of any vacancy arising in the office of the Chief Trustee, Managing Trustee or Trustee-Cum-Secretary by death or resignation the remaining Trustees may fill up the posts from among themselves by elections; b) In the case of any vacancy in the Trust Board arising by death or resignation, the remaining Trustees will have full powers to represent the Trust Board, and to fill up the vacancy.

7. Any Trustee shall be at liberty at all times to retire from the Trust and shall

also be liable to be disqualified to hold office if he becomes or is declared to be an insolvent or to be of unsound mind whether or not found by Inquisitioner shall become unfit or incapable to act as a Trustee.

8. The Trustees will be entitled and be at liberty to accept gifts or any voluntary contribution from any person install charity boxes and/or to collect subscriptions donations to augment the Trust Fund and use such monies for the objects of the Trust. 11. The Trust shall be managed by the Chief Trustee-Cum-Treasurer, Managing Trustee and the Trustee-Cum-Secretary in consultation with each other and they shall have the powers of day to day management and administration of the Trust.

It is hereby agreed that in matters of policy and carrying out the objects for which this Trust has been founded, Trustee shall prevail.

12. The Chief Trustee-Cum-Treasurer may attend to the work of corresponding with Central Government, State Governments, local authorities, other institutions or bodies set up by Central or State Governments for attending to matters connected with education in general and popularisation of specialised studies in particular.

13. Without prejudice to the generality of their powers, the Trustees shall have powers atleast by way of opinion of the majority of the Trustees. 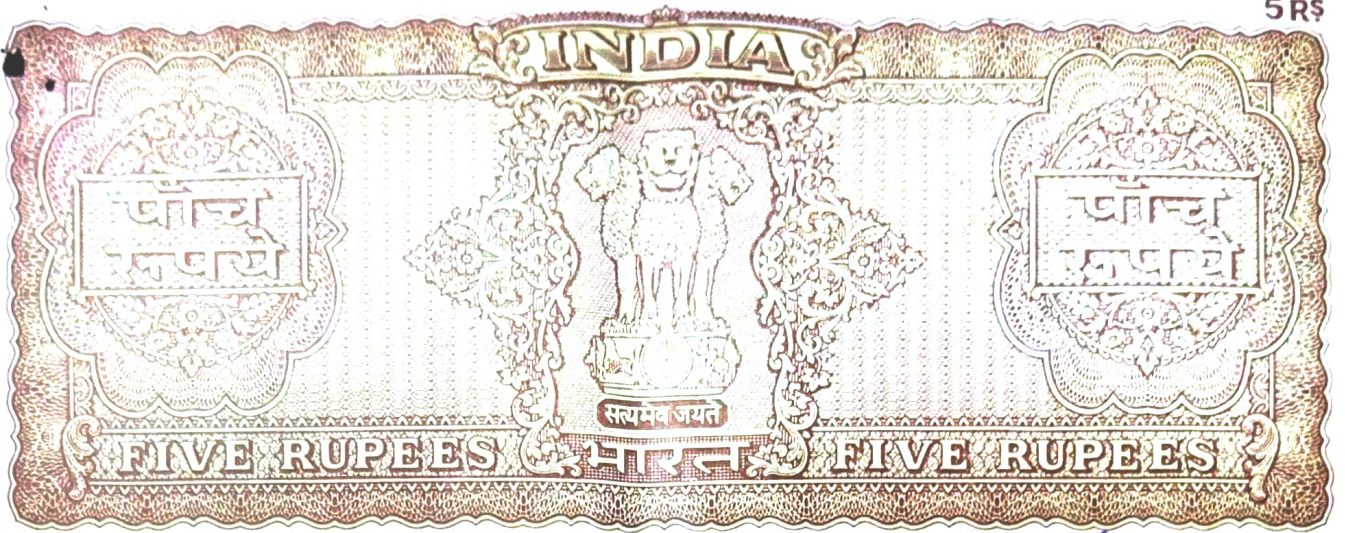

17. The Official year of the Trust shall be from April to March.

If for any reason, it is found that it may not be practiceable to continue the activities of the Trust, then the funds of the Trust shall not be divided among the Trustees in any manner, what so ever but shall be handed over to another Public Charitable Trust or Institutions as the majority of the Trustees may decide.

19. The Trust shall be Irrevocable.

20. The Trustees shall at all time stand indemnified in respect of any act which may have been bonafidely done by them in respect of the matters relating to the Trust.
